- 1. All tenants must have renters insurance.
- 2. Installation or application of wall hung shelves, wallpaper, paint, brackets, ceiling hooks, extra locks, or marring the walls, woodwork, or doors is NOT allowed.
- 3. Do NOT use counter tops for cutting food. Use a cutting board!
- 4. Malfunctions of plumbing or other mechanical devices must be reported to Marty Gaffey at 358-0111 <u>immediately</u>. Light bulbs and smoke detector batteries are the tenant's responsibility and must remain with the apartment upon departure. <u>Repairs due to tenant neglect will be billed back to tenant</u>, and other repairs deemed as ordinary wear and tear by Marty Gaffey will not be.
- 5. All tenant's personal belongings should be kept in their unit.
- 6. Garbage disposals are for small food particles only. Grease, bones or other foreign materials should be put in garbage bags and disposed of in the dumpster or regular collection area.
- 7. Toilet paper is the only thing that should be put in the toilet commode. <u>Plugged toilets due to other items will be billed to the tenants.</u> Tubs and shower stalls should be cleaned regularly with a non-abrasive cleaner. **NEVER** use steel wool or scrapers.
- 8. Loud stereo, television, or other such conduct depriving your neighbors of their peaceful enjoyment of the property is **NOT** allowed.
- Open parking is limited to tenant owned vehicles in the assigned areas or the vehicle may towed at the vehicle owner's expense. Parking spots are for TENANT ONLY. Only use parking spaces assigned to apartment
- 10. All garbage is to be placed inside plastic bags, tied shut, and placed in the garbage collection area (dumpster, etc.). All boxes are to be broken down and taken to City Carton to recycle. Large furniture items are to be removed by tenant. <u>If removed by landlord, cost of removal will be</u> <u>deducted from your deposit.</u>
- 11. **ABSOLUTELY NO** smoking, live Christmas trees, alcohol burners, kerosene heaters, space heaters, water humidifiers, or any type of open flame or <u>candles</u>,
- 12. If the lease is broken before full term, YOUR DEPOSIT WILL BE FORFEITED. Death or terminal illnesses are the only things that will allow breaking of your lease. If the lease is broken for any other reason, then the tenant will be responsible for the rent payments through the end of the lease period.
- 13. Sublets granted by approval ONLY, and will forfeit deposit.
- 14. Absolutely NO garage sales allowed!
- 15. NO satellite dishes are allowed.
- 16. Absolutely NO PETS OF ANY KIND; Dogs, Cats, Etc. with the exception of a service animal.
- 17. Stove, refrigerator, air conditioner, curtains/blinds are provided. They should be cleaned and in same condition upon departure.

- 18. Carpets are to be PROFESSIONALLY cleaned upon departure, and a receipt MUST be obtained or it will be taken out of your deposit.
- 19. Water leaks need to be reported within 24 hours or tenant is responsible for water bill.
- 20. Windows need to be closed during winter months or tenant will be charged \$25.00 on each occurrence.
- 21. All rent checks should be made out to: Marty Gaffey.
- 22. If you're late with rent three times in a row you will be evicted.
